

On-line implementation of Pre-matric, Post-matric and Merit-cum-Means Based Scholarship will be done through the common National Scholarship Portal at [www.scholarships.gov.in](http://www.scholarships.gov.in) (a link of the site is also made available in the website of this Ministry i.e [www.minorityaffairs.gov.in](http://www.minorityaffairs.gov.in) of Mobile App- National Scholarships (NSP). Only online applications under these Schemes will be accepted and no request for Offline applications will be entertained. It will be necessary for the eligible applicants to provide Aadhaar number while applying for scholarship and in case an individual does not possess Aadhaar one can provide the details of alternate identification documents as stated in the Gazette Notification available on National Scholarship Portal (NSP).
